RECORD OF INITIAL APPEARANCE

The Defendant appears before the Court on the following charge(s):

- 01 - 709.4(1)(a) - SEXUAL ABUSE - 3RD DEGREE
- 02 - 709.15(4)(a) - SEXUAL EXPLOITATION BY COUNSELOR OR THERAPIST
- 03 - 726.6(7) - CHILD ENDANGERMENT

A not guilty plea was entered on any simple misdemeanor companion charges. Those charges are to continue along with the above case unless a request is made.

Order for Appointment of Counsel

Based upon the Defendant's Financial Affidavit/Application for Appointment of Counsel, the Court finds as follows:

The Defendant's income is between 125% and 200% of the guidelines and not appointing an attorney would cause a substantial hardship.

The Defendant's application for court-appointed attorney is granted.

The Public Defender's Office is appointed to represent the Defendant.

Order Setting Conditions of Release

Pursuant to the application for release, the Court hereby Orders:

1. The Defendant shall personally appear at all proceedings in which his/her personal appearance is required by law or ordered by the Court.
2. The Defendant shall keep his/her attorney informed of his/her whereabouts at all times.
3. Conditions of release are as follows:

The Defendant is released to the 8th Judicial District Department of Correctional Services for pretrial supervision.

The Defendant shall remain in the State of Iowa during the pendency of these proceedings.

The Defendant shall post a bond in the amount of \$500,000.00, cash only
Pursuant to Iowa Code Section 690.2, the jail SHALL NOT release you until your fingerprints have been obtained if you have been charged with a simple misdemeanor Theft, Domestic Abuse Assault, or Public Intoxication, or you are charged with a serious or aggravated misdemeanor or felony. If you were issued a citation and were not arrested, then within Five (5) days of your initial appearance you SHALL report to the jail for fingerprinting or be subject to contempt and immediate arrest.

Order Scheduling Preliminary Hearing/Next Court Appearance

The Defendant demanded preliminary hearing.

Preliminary Hearing is scheduled on 09/18/2017 at 11:00 AM at the S Lee Co Courthouse, 25 North 7th, Keokuk, IA 52632.

If the defendant bonds out of jail, he shall immediately report to the Department of Correctional Services to sign up for pretrial supervision.
